Part A: Pupil premium strategy plan

Statement of intent

Our Vision is to inspire everyone to flourish, grow and learn in a safe and spiritually rich environment.

Our Ethos is to Believe, Achieve, Belong

- Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.
- The knowledge-rich curriculum at Flourish Federation supports our vision and is supported by quality-first teaching and strong subject leadership.
- Our strategy incorporates a strong approach to behaviour for learning with high attendance for all children.
- SEND provision is strong for all children with early identification of needs and delivery of targeted interventions.
- Meeting the needs of our children by ensuring that there is a high level of purposeful engagement with our families in order to support children's high attendance, self-regulation and an aspirational approach to learning.
- Strong, integrated early years provision with All Saints Nursery, to improve outcomes from reception to Year 6 by supporting early learning goals, resilience, self-regulation and early identification of additional needs.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Pupil behaviour can be challenging and this is more prevalent in disadvantaged pupils. Pupils lack resilience and good behaviour for learning.
2	Attendance for the Pupil Premium cohort is currently 2 % below peers and national figures.
3	Progress for pupils who are eligible for Pupil Premium is lower than for non-Pupil Premium children. This has resulted in significant knowledge gaps leading to pupils falling further behind age-related expectations.
4	We have identified social and emotional issues for many pupils, this could be a result of lockdowns and a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment.

5	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics than their peers. This negatively impacts their development as readers.
6	Our assessments and observations indicate that the education and wellbeing of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are supported by national studies. This has resulted in significant knowledge gaps leading to pupils falling further behind age-related expectations.
